Assigned Readings: The substantive readings are contained in a photocopied, bound "bulk pack" available from Wharton Reprographics on the basement level of Steinberg-Dietrich Hall. The current plan is to cut the pack into three parts, the first part to be available at the outset of the semester. Many additional handouts, often reflecting recent developments, will be given out in class. Wharton Reprographics will assess a fee for these additional handouts at the end of the semester.
