#### **OVERVIEW**

This course examines the various components of the U.S. health care system and how the components interact with one another. We begin by examining the role of medical care in producing health and the costs and benefits of new medical technologies (e.g., medical devices and prescription drugs). We then examine the objectives and behavior of key stakeholders in the system: consumers, employers, and taxpayers who pay for health care; private and public (i.e., Medicare and Medicaid) health insurers who manage the funds; physicians and hospitals who actually provide medical care; and pharmaceutical and medical device firms that supply products. Students will also learn how to apply basic economic reasoning to examine health policy issues, including covering the uninsured, controlling the growth rate of medical spending, improving the quality of medical care, and reforming the malpractice system.
