OVERVIEW

This course examines the various components of the U.S. health care system and how the components interact with one another. We begin by examining health care expenditure and the role of medical care in producing health. We then examine the objectives and behavior of key stakeholders in the system: consumers, employers, and taxpayers who <u>pay</u> for health care; private and public (i.e., Medicare and Medicaid) health insurers who <u>manage</u> the funds; physicians and hospitals who actually <u>provide</u> medical care; and pharmaceutical and medical device firms that <u>supply</u> products. Students will also learn how to apply basic economic reasoning to examine health policy issues, including covering the uninsured, and controlling the growth rate of medical spending.
