Issues that are identified, analyzed, and explored include athlete representation, labor law, antitrust exemption, arbitration, collective bargaining, salary cap administration, free agency and the application of ethics as a method in the decision making and problem solving process.

Explain the history and structure of sports leagues and unions. 7. Summarize the general principles of agent regulation with particular focus on the NFLPA Regulations Governing Contract Advisors. 8. Understand the basic economic framework under which professional leagues and players associations operate with particular focus on the salary cap/free agency/revenue sharing system of the NFL/NBA/NHL. 9. Theoretically negotiate a standard Player Contract in compliance with the terms and conditions of the salary cap systems and CBA. 10. Develop a better understanding of how to make decisions and solve problems with an eye toward the relevant legal and ethical issues in sports.
