**Assigned Readings:**

1. **Bulk Pack:** The substantive readings are contained in a "bulk pack" of readings available online at Study.Net. The readings appear in the order that they appear in this syllabus. Please look for the bulk pack by the course name and the professor's name, as it is specific to this section. Additional handouts will be used in class during the semester and will be posted in the course site in Canvas. Please note: you must download THIS semester's online bulk pack. Please do not rely on bulk packs from years past.
2. **Slides:** The slides used in class will be posted on Canvas .
3. **Selections for Contracts:** (Foundation Press). This book may be purchased at the Penn bookstore and contains statutes we will be using in the second part of the course, dealing with contracts. However, you must purchase this book now. **These books may not be available later in the semester** and you will be at a severe disadvantage if you don't have your own copy.
4. **Cases:** *Please bring copies of the assigned cases to class, as we will refer to them during class discussion, and you will need to have them with you.* You do not need to bring other assigned readings to class. During the second half of the course (Contracts), you will also need to bring the pamphlet *Selections for Contracts* to class, in addition to the assigned cases.

You should complete the assigned readings before the class, especially the assigned cases, since lectures and discussions proceed on the assumption that you have done so.

Your class participation grade will in part depend on your preparation. At some point during the semester I will be calling on you randomly to discuss the assigned cases, and you should come to class prepared to do so. Make sure before you commit to this Legal Studies 101 Section that your schedule will permit you to fulfill this class requirement.

## Class Requirements:

### 1. Examinations:

There will be two examinations. The first examination will be closed book. The second will allow you to use your Selection for Contracts pamphlet.

**The first exam will take place IN CLASS on WEDNESDAY, OCTOBER 14. It will be part multiple choice and part short answer. It will cover all material discussed in class through October 12, 2015.**

**The second exam will take place IN CLASS on MONDAY, NOVEMBER 23. It will also be part multiple choice and part short answer. It will not be cumulative so it will cover all material discussed in class between October 12, 2015 and November 18, 2015. You will be able to bring your UNMARKED Selections for Contracts pamphlet to the second exam.**

The first examination will count for forty (40) percent of your grade. The second examination will count for forty (40) percent of your grade.

Please make sure now, before you commit to this course and section, that you have **no conflicts with these exam dates**. Please, therefore, check your Christmas travel plans; interview schedule; extracurricular events [sports, plays, concerts]; family events [reunions, weddings, bar/bat mitzvahs]; and get a flu shot. Before registering for this course, you will be required to check a box on Canvas that affirms that you have checked your calendar and that you have no conflict with either exam date. Please put the exams on your calendars **NOW**. There will not be a makeup for either examination.

**For all exams: If a topic has not been covered in class, it will not be on the exam.**

### 2. Contract Simulation (November 30-December 7).

On **November 30, 2015**, I will hand out a contract simulation problem. This problem will be done in groups of 6-7 students.. This exercise is unique to this section of LGST 101.

You may form your own group and submit the names to me by email anytime on or before **November 20, 2015**. If you have not done so by that date, I will assign you randomly to a group.

Each group will be responsible for negotiating and drafting a no longer than **5-page written contract** based on a set of given facts. This group problem will receive a group grade, which will count for 15% of your individual grade.

Class time during the final week of class will be devoted exclusively to this exercise. On December 2, 2015, there will be an in class final negotiation session during which I will be available to advise each group.

Final contracts (and backup documents as set forth in the problem) will be due on the last day of class, **December 7, 2015** at 12 noon. They should be delivered to me via email at [jmarston@wharton.upenn.edu](mailto:jmarston@wharton.upenn.edu) in both PDF and Word. There will be no class that day.

3. **Class Participation**

Informed class participation will count for 5% of the grade. As noted, I may call on students at random to discuss assigned cases, and this will be a part of your class participation grade. Attendance is not part of your class participation grade, but is a class requirement.

4. **Schedule**

5. **Dropping or Withdrawing from the Course**
