### **COURSE OVERVIEW**

By recognizing the importance of scarcity and incentives, the Economics and Financing of Health Care Delivery focuses on the critical economic issues we face when consuming, producing, delivering, and financing health care. This course will analyze the demand for and supply of health care; the unique roles of insurers, providers, and other industries in health care delivery; and the economic phenomena pervasive in the market for health care, including asymmetric information, externalities, and the lack of price transparency. Special emphasis will be placed on the evaluation of government regulations, the current and future roles of public health systems, and the ability to dissect economic and political issues in ongoing policy debates.
