Course Description

The purpose of this course is to introduce techniques of financial analysis, with applications to corporate finance. The concepts learned in Finance 100 are the foundation for all elective finance courses. The topics covered include: (1) time value of money and the net present value rule, (2) capital budgeting decisions, (3) portfolio choice, (4) valuation of bonds and stocks, (5) corporate financing decisions, and (6) options.

Grading

Grades will be based on the final and midterm exams (they worth 45% and 35%, respectively) and two quizzes (20%).

Exams:

There is one Midterm exam and one Final exam. The Midterm and the Final can be taken at any time in the allowed exam window, but once you start you will have 120 (consecutive) minutes to complete each exam. Once you start the exam, you cannot pause it and restart it at a later stage. Exams will be performed online within Canvas platform. There will be **no** makeups of the midterm exam or final exam, except in extenuating circumstances covered by university policy (i.e., medical emergencies). The syllabus shows the exam schedule—so schedule your plans not to conflict with them. I am not responsible for the date of the final exam, it is decided solely by the university.
