OVERVIEW

This course examines the structure of health care systems in different countries, focusing on the design and financing of public and private insurance; the organization of healthcare delivery systems; reimbursement of physicians, hospitals, pharmaceuticals and devices; the adoption of new technologies and expenditure controls. We study the relative roles of private sector and public sector insurers and providers, and the effect of system design on cost, quality, efficiency and equity of medical services. Some issues we address are normative: Which systems and which approaches to combining public and private sectors are better at achieving equity? Other issues are positive: How do these different systems deal with the tough choices, such as decisions about the adoption of new technologies and how efficient are they? We will cover some mature systems, including Germany, the United Kingdom, and Japan, which represent prototypical system designs. We will also look at middle and low income countries with emerging systems –including countries in Latin America, such as Chile; Africa such as Kenya, Rwanda and South Africa; and Asia (India and China) – and at major cross-cutting issues such as life-expectancy, infant mortality rates, and service quality. We will draw lessons for the US from foreign experience and vice versa.

TERM PAPER AND PRESENTATION

Students will write a brief (about ten pages) paper related to the health care system in one or more countries. You may work in groups of up to two students, or individually. Possible topics include: how a particular country has dealt with a costly technology or service, such as cancer drugs, long term care or electronic medical records; the role of private vs. public sector in insurance or service provision or medical education; specific health issues, such as smoking etc. The US should NOT be the main focus of the paper, although it may be used for comparison. The paper should also not replicate material covered in class or in the assigned readings. The **paper is due in class on April 4**. (NO EXCEPTIONS). Please submit an electronic copy of your paper via Canvas.

Starting April 4, you will present your papers to the class and the order of presentation will be assigned in reverse order from the time we receive your e-mail communicating your group composition. The presentations are twenty five minutes and there will be about 10 minutes for questions from your classmates and discussion. Be prepared to present twenty five minutes, with no more than ten slides.
